LANDLORD'S CONSENT

In consideration of the installation of equipment by GT Group Telecom Services Corp. ("G \(\text{\Gamma}' \)) to enhance telecommunications services of the tenants located at (see Schedule "A") ("Complet"), CARKIM CORPORATION, as agent ("Landlord") consents to such installation on the following to ms:

- GT may install, maintain and operate its telecommunication equipment in a cordance with drawings attached;
