This page sets out information which is referred to and forms part of the TELECOMMUNICATIONS LICENSE AGREEMENT made as of the 19 day of January, 2007 between BROOKFIELD PROPERTIES CORPORATION as the Licensor and BELL CANADA as the Licensee.

The information is as follows:

Building: The building municipally known as Place de Ville, 320 Queen Street, in the City of Ottawa, and the Province of Ontario.

Floor Area of Deemed Areas: Room "104a" - space deemed as 253 square feet.
Room "Concourse" -space deemed as 180 square feet

Commencement Date: the first day of December 2006

License Fee: Room "104a" - the annual sum Six Thousand Three Hundred and Twenty-five dollars (\$6,325.00) calculated based on the annual rate of Twenty-five dollars (\$25.00) per square foot of the floor area of the Deemed Area.

Room "Concourse" - the annual sum Four Thousand Five Hundred dollars (\$4,500.00) calculated based on the annual rate of Twenty-five dollars (\$25.00) per square foot of the floor area of the Deemed Area.

The exact measurement of the Deemed Areas may be verified by an architect or surveyor employed by the Licensor for that purpose and upon verification, an adjustment of the License Fee and the floor area will be made at the next anniversary of the Commencement Date.

Hydro Rates: Room "104a" - \$600.00 plus GST paid annually in advance. *See Clause 6, "Electrical Utilities".
Room "Concourse" - \$ 600.00 plus GST paid annually in advance. *See Clause 6, "Electrical Utilities".
