#### LANDLORD'S CONSENT

In consideration of the installation of equipment by GT Group Telecom Services Corp. ("GT") to enhance the telecommunications services of Manitoba Hydro ("MH") at the premises of MH located at 820 Taylor Avenue in the City of Winnipeg (the "Premises"), MH consents to such installation on the following terms:

- GT may install, maintain and operate its telecommunication equipment at the Premises in accordance with drawings attached as Appendix A.
- 2. Access to the Premises shall be provided on the following basis:
  - a.) 24 hour /7 days a week access for emergency repair or loss of service
  - b.) After two working days notice for routine maintenance or inspection.

The process for MH to provide access to GT shall be as defined in Appendix B, attached.

- 3. All initial and future equipment supplied by GT shall remain the property of GT, and will be installed, operated, maintained and relocated by GT in a good and workerlike manner in accordance with sound engineering practices and all applicable legislation. GT shall obtain and maintain all licenses required to operate the equipment. If MH, acting reasonably, should for any reason terminate all service provided by GT, then MH may terminate this agreement upon 30 days written notice and GT shall remove all equipment and restore the Premises to their original condition, reasonable wear and tear excepted.
- 4. GT shall indemnify MH for any personal injury or property damage caused by GT, its employees or agents and GT will provide MH with a certificate of insurance with coverage of not less than \$2,000,000 noting MH as additional insured in a form acceptable to MH acting reasonably.
- 5. GT may connect its equipment to the electrical systems and utilities of the Premises including telephone and fibre. Where applicable GT may connect to the interior wiring, cabling and the equipment as necessary to install, maintain and supplement GT's facilities used to provide telecommunication of signals to and from customers located at the Premises. GT will obtain all necessary approvals, work permits, clearances and in all other respects comply with legal requirements before making the connections described above. All connections are made at the risk of GT.
- 6. MH may assign this agreement at any time and shall be relieved of all obligations to GT under this agreement, provided MH ensures that the assignee receives actual notice of this agreement. GT may effect a transfer to a corporate affiliate, its senior lenders or their collateral agents or a purchaser of a material portion of its business. GT shall ensure that MH is informed of a transfer and except for a transfer to a purchaser, shall remain liable under this agreement.
